 - o If lease aid goes through by June 30th it will change.
- 77% state revenues
- 51% Federal Rev.
- 104% local

 - Will check the coding of ESSER and SPED budgets
- Through March exceeded spending by (+)221,423
- Total loss of 50,643
- 577,272 in, 829,490 out (expected)

 - Next year's budget draft
 - 530ADM total
 - Inflation rate 4%
 - ESSER III about 425k left over (expires Sept. 2024)
 - o 10m total revenue budget (130 more ADM)
 - Staff increases at 3%
 - Asked about a percentage increase from the transportation company?
 - Dr. Henderson will look into this.
 - o Building rent is set 920k
 - Summer school, after school, and parent academy will now come from general funds
 - pre-k is funded by ESSER
 - o beyond 23-24 school year pre-k will shift back to the general fund. (\$124,723)
 - o Food Service How will the new law affect this?
 - Not sure yet
 - Think it will cover food, but will still cover staffing
 - With our high free and reduced lunch population, might not affect us much
 - Dr. Henderson asked about the days cash on hand being 86 from 104
 - this puts us below the required 90
 - Ms. Abbs will revisit this.
